Get Ready for Tax Time

Easily access your UECU tax forms online. Your tax E-Forms are delivered securely to your account in Mobile and Online Banking.

To download the forms, log into Mobile or Online Banking, select Documents and Statements from the menu, and then choose the tab for Tax Forms & Notices. **UECU Tax forms are typically available online by January 31st.**

To set up direct deposit for your refund, include UECU's routing number, 231385633, and your 14-digit MICR Account Number, which you can find at the bottom of your checks or by logging into Mobile or Online Banking. Select your account to view your MICR Account Number under Account Details. Click the eye icon to reveal the protected information.

Are you a former NE PA Credit Union member? To set up direct deposit for your

tax refund to your new UECU Checking Account, be sure to include your new UECU 14-digit MICR Account Number and UECU's Routing Number, 231385633. You can find your 14-digit MICR Account Number in digital banking. Log into Mobile or Online Banking, and select your account to view your MICR Account Number under Account Details. Click the eye icon to reveal the protected information.
