You acknowledge that the emails or text messages may not be encrypted. You may change your *E-Notifications*<sup>TM</sup> options or discontinue receiving *E-Notifications*<sup>TM</sup> by going to *Advantages Online*<sup>TM</sup> in the Services section and updating your preferences on the *E-Notifications*<sup>TM</sup> page.

UECU reserves the right to terminate this service at any time. We will only allow you to register one e-mail address or cell phone number with us at any time. You are responsible for notifying UECU when you change your email address or cell phone number. If an email or text message alert or notification is returned to UECU as undeliverable, UECU may discontinue your *E*-*Notifications*<sup>TM</sup> service. The *E-Notifications*<sup>TM</sup> service runs 24 hours a day, 365 days a year. You may receive an alert or notification at anytime of day or night. UECU does not guarantee the timeframe within which an alert or notification will be delivered.
